Golf Australia is very clear in its rules on amateur status and specifically allows vouchers to be credited to House accounts in anticipation of purchases of food, beverages or other goods from the Club or other retailers, but they cannot be used for expenses already incurred. **Furthermore the use of vouchers for payment of membership subscriptions and competition fees is specifically prohibited.**

Therefore the way in which we allow vouchers to be used is perfectly in line with the rules because we do not allow any House Account to go into debit. Vouchers put to a House Account is applied in anticipation of future purchases, so don't shoot the messenger – we only apply the rules; we don't make them. An extract from the relevant part of the rules has been placed on the notice board.

Practice Levy – all members should be aware that a voluntary levy of \$2 is payable every time the course facilities (with the exception of the putting green) are used for practice. Two or three holes, the practice area or a full round of 18 holes is the same flat fee - \$2.

It's not a lot to ask but it is important to our finances. Our revenue from this source has dropped \$3,500 in just 3 years and that is a significant amount of money. We know some members are using the course and not paying the levy and we know course traffic has not declined generally

The levy can be paid to the Pro Shop or to the Bar – but we need you to pay every time.

Facebook – we are moving to the new networking social media very shortly. We are in the process of looking to upgrade/update our web page and we now have a FaceBook page. Why don't you check it & LIKE it to be kept up date with what's going on! Twitter NEXT!

We know, too, that all of that will mean little to many members but we believe we need to keep up with new technology and trends if we are to lift our profile and improve our marketing strategies. It's a competitive world out there and we have to work hard to keep what we have and perhaps try and pinch a little bit extra from others.

MATTERS IN-HOUSE

House account – a final reminder that any money paid with your membership renewal last year to your House Account must be fully spent by 30th June or any part unspent at that time will be forfeited.

At the time of writing there are just 16 members who have some of that money left (a total of about \$1,500 ranging from \$28 to \$228) and each has been sent a reminder letter but time is running out.

State of Origin – the first State of Origin game has been and gone and although we didn't have a huge crowd at the Club, we did have a very convivial night watching the big screen.

We'll do it again **next Wednesday with free sausage sizzle, \$3 schooners** and great hope for a different result. The kids play area will be open as well so come along and enjoy it with us.

Friday night – and don't forget the members draw for tee times at 6.30pm every Friday night followed by live, free entertainment. The Bistro is open, the kids play area upstairs is open and also free of charge and we have schooners at \$3 each from 6pm until 7.30pm. Come and spend a Friday night with us; even the kids will enjoy something no-one else has in the area.

FINANCES

The club continues to do it tough and we struggle to trade profitably when we are effectively only open one night of the week – Friday night.

The gaming machines do well for us but we only have 15 of them so potential is restricted. The TAB costs us money and we maintain that as a service to members but its support is limited and unlikely to improve to a point where it becomes revenue positive. Bar pricing is being maintained at a minimal profit level but requires volume to make a meaningful contribution to the bottom line and, unfortunately, the volume continues to decline.

Private functions, mostly on Saturday night, have always been a good source of revenue but unfortunately don't happen every week although we would welcome more of them. You can help by spreading the word that the Club can be 'hired' for up to 100 people without charge with drinks at normal bar prices. Nowhere else in the area can you book a function with no room hire charge.

BOARD OF DIRECTORS
